



## Completion of the strategic agreement for Beni Stabili with Crédit Agricole Assurances and EDF Invest on Telecom Italia portfolio

**Milan – 21 June 2017:** Following signing in November 2016, Beni Stabili, the leading property company in the Italian real estate sector and owned at 52% by Foncière des Régions, has closed today the disposal of 40% stake in the largest Italian Real Estate SICAF formed earlier this year via the contribution of all its Telecom Italia portfolio (for a value of approx. €1.5bn), along with the associated debt (approx. €0.8bn).

Crédit Agricole Assurances and EDF Invest, the investment division of the EDF Group, have each acquired a 20% stake in the SICAF from Beni Stabili. Beni Stabili maintains control over the SICAF through its 60% stake and will also provide real estate services to the SICAF.

This landmark transaction confirms the appeal of Italian real estate for long-term international investors and constitutes a key stage in the strategy initiated by Beni Stabili at end-2015:

- **Diversifying further its tenant base.** Telecom Italia exposure, will decrease to 27% of its portfolio after the SICAF operation vs 38% of its portfolio at end-2016 before the transaction

- **Strengthening capital structure.** Thanks to this transaction, which represents an equivalent of around €620 million of Telecom Italia assets, LTV 2016 pro-forma is below 45% vs 51.6% before the transaction.
- **Increasing its exposure to Milan,** with 60% of the portfolio vs 53% at end-2016, on track to its 80% target by 2020.

Through the strength of its rental partnerships, its quality-enhancing portfolio rotation policy, and its dynamic development projects in Milan, Beni Stabili is steadily working towards its real estate ambition, offering a financial profile which combines value creation and solid revenue over the long term.
